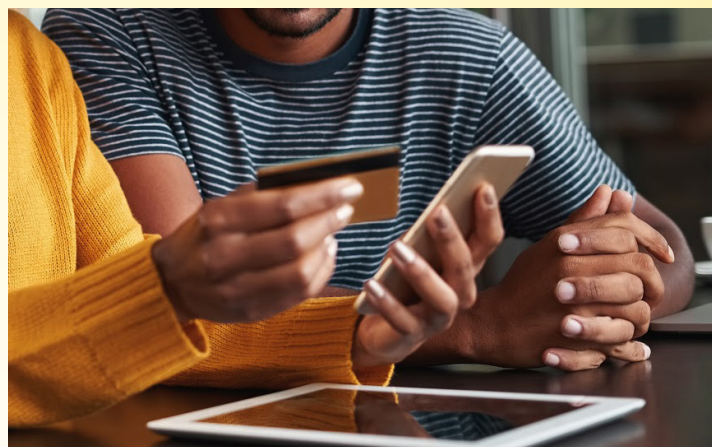
DRESSING CODE
