QUESTION ONE

Ms Kananga Jane is the Associate Director of 'EJO NEZA'a non- profit organization that helps children and poor families. She is in charge of evaluating the capacity building programs that the organization offers to families. She reports directly to the Ministry of Gender and Family promotion. Because of the high competition of for federal grant funds, the agency has been cautious in recruiting this year. They have experienced high turnover of five (5) personnel in research and finance departments.

Kananga has everyday tight schedule that requires regular travel; nevertheless, she oversees two (2) managers Keza Nancy and Kabondo Joel each of whom is in charge of five staff members. Both managers were hired during the previous six months.

The first manager is Keza who has a strong research background and supervises staff who provide research support to another department that provides mental health to children. She is incredibly organized and encouraging her staff. She is highly motivated and driven and expects the same from the staff under her supervision. Keza's recent research on the therapeutic divisions' services is valued by the top management.

The second manager Kabondo who is experienced in social science research and evaluation supervises employees that work on various projects within the organization. He is known as a problem solver and is very supportive to his staff under his supervision and the organization as whole. He is very organized and has much expertise in evaluating family services.

Both managers are concerned that staff are getting overworked as everyone assumes greater responsibilities due to the high turnover at the company. Ejo Neza's staff have also mentioned that Ms Kananga's 'glass half empty' conversation style leaves them feeling depressed. In addition, Kananga has not shared budget information with managers, which has made it hard to appropriately allocate work to personnel. Kananga said he has not received enough information from the finance department to complete the budgets. In a meeting, the Finance Department stated that they have provided all the information on time. Managers become frustrated as their staff become anxious. They feel like they are unable to advocate for their staff or solve problems in the absence of critical information such as departmental budgets.

Recently, Officers from the Revenue Authority visited Kalisa & Associates' offices and asked John for information and data on the company's sales and exports and John provided as well. Kalisa & Associates' policy and guidelines do not allow employees to share any information and other confidential data to any third party without the client's prior consent. John Kidebe was harassed, fired as in the context that he disclosed sensitive documents information to third parties without the authorization from Marangara Coffee Limited. The management wrongly considered this case as whistle-blowing.
