Exemptions & Retention of Credits

Exemptions may, upon formal request be given to registered students who are holders of certain degrees, certificates and diplomas recognized by iCPAR and are granted on a paper by paper basis.

Papers taken and passed in a level shall be **RETAINED** as CREDITS provided that the candidate enters and attempts all the papers or unless the candidate is granted exemptions from some papers in the level or has earned credits in previous attempts.

Further, a candidate who is awarded credit(s) in a sub-level must enter and pass the failed papers in the level in three or six years sitting that follow, failure to which the candidate will be required to sit all the papers in the sublevel.

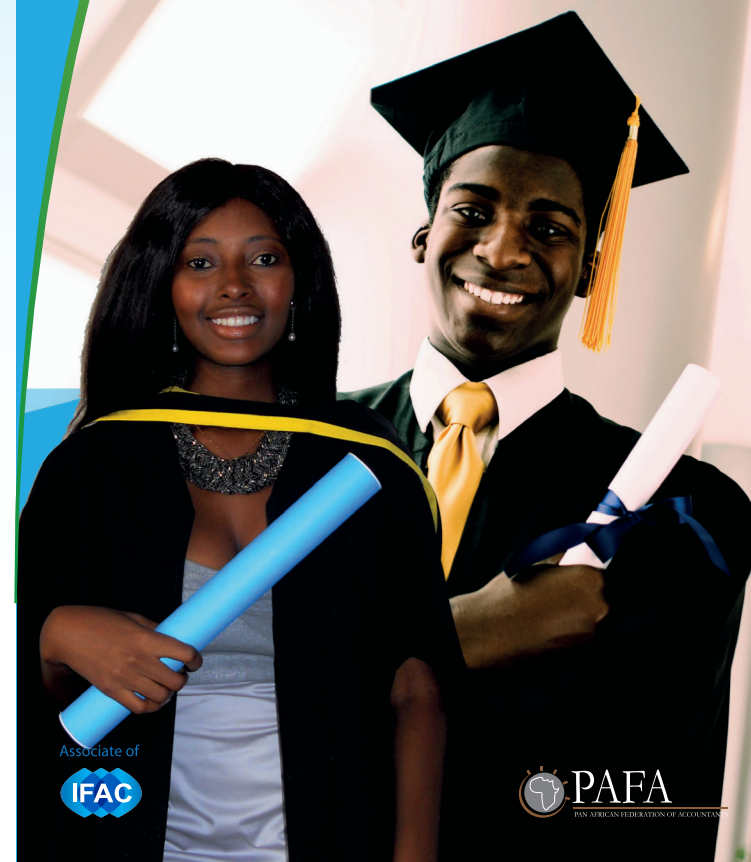

Certified Public Accountants (CPA) Entry Requirements

- Senior six examination score of at least 30 points or its equivalent
- Holders of the Certified Accounting Technician Certificate
- Holders of a Bachelor's Degree or Diploma in Accounting, or Accounting
- Certificate from a recognized university/tertiary institution or professional body
- Third year university students specializing in accounting or business studies
